Welcome	Steve Ramos, President of the EWHA Board, called the monthly meeting to order at approximately 7:05 p.m. Approximately 35 people attended the meeting in person. No Zoom option was provided.	None
1. Assembly Minutes	The June 4 General Assembly Meeting minutes have been posted on the website. Minutes were approved, as submitted.	June 4 meeting minutes approved.
2. Cincinnati Police Report	Officer Perry Locke presented the crime statistics for August. Crime Noted: 0 Aggravated Assault 0 Burglary/Breaking & Entering, 2 Theft from Auto, and 3 Auto Theft 2 Personal Thefts. Remember to keep important items in the trunk to keep auto thefts down. Additionally, if things are stolen, please report it to the Police. Reporting incidents will help ensure resources are appropriately deployed. School is back in session, so be careful, watch for children, and don't speed, particularly in the morning. Drones can pick up speeders as well. A resident raised concern about trespassing at Woodburn Exchange where someone was following women into the building. Officer Locke will talk to the building manager and Police Investigator. 3. Bush Recreation	Renovations are being completed thanks to city sponsors, including the Reds, P&G, and the Zoo. Pickleball is on Tuesdays and Thursdays from 6-8PM. Just remember this is a recreational league and not overly competitive. The Clifton Community Center is hosting a free bike repair event on Saturday, September 20. Trunk or Treat will be Friday, October 31from 3-6PM; feel free to donate candy or attend. The Community Center hours are 11AM-8PM and memberships are very affordable.	None

4. Treasurer's Report	Brandi Yoder presented the July Treasurer's report on behalf of Vince Accorinti. The report was available at the meeting and was posted on the website prior to the meeting. The only extraordinary item is a higher parking revenue than normal. Multiple months' deposits were made in July due to executive committee rotations. As a reminder, the fiscal year ends at the end of June. There was a request to share the final 2024-2025 Treasurer's Report at the next meeting since the Assembly did not meet in July. That way the full Assembly can understand the full year financial picture.	None
5. Pocket Park / Public Art	Jinny Berten and Tony Fisher reported. Pocket Park: There were issues with landscaping, but they were resolved and cleaned up. Additionally, during the construction, the water pipe was damaged and the cost to repair it is ~\$14,000. Tony is working with CHMA to resolve the immediate fix and a better design for the longer-term.	None
6. Development	 Tony Fisher and Drew Gores reported. DCDC is the first line to work with developers. Their current focus is: Expand the Hackberry / Cleinview historic district. More to come, both in the Assembly and for those that live in the area. Update the neighborhood plan (essentially a strategic plan); EWH's is old and needs to be updated. This is important because the city refers to it when looking at developments in the neighborhood. Kemper and Columbia development appeal hearing is on Oct 3 if anyone wants to attend. 	None
7. Membership	Chris Davis reported. The membership drive will now take place in November. However, everyone is encouraged to renew their membership online, which they can do now.	
8. Parking	Jeff Butterbaugh reported. There is a broken pole in the Woodburn lot. The replacement part is ordered and should be installed in mid-October. In the Madison lot, permit parkers need to move from the southeast corner for the Farmer's Market every Friday.	
9. Additional Business	The Candidates Forum will be held during next month's Assembly meeting, October 1 from 7-9PM. All 26 candidates running for City Council have been invited to attend. From 7-8PM they will provide introductions and the League of Women Voters will introduce the issues. Then from 8-9PM the candidates will be seated around the room. Constituents can rotate between tables, asking candidates questions, in a speed dating format. If you want to volunteer, let Kimberly know. This event is in partnership with Walnut Hills. They will bring refreshments and EWH will host. The October 1 Assembly meeting will not cover any general business topics; the Candidates Forum will take over the meeting. Information will be sent out and we will post it on the website. Shannon Miranda is leading a Young Adult Campaign, which is generally targeting adults 18-35 years of age. The campaign will help young adults understand how to become involved, how to become Assembly members, and why it is important to be a part of the neighborhood. The kickoff will be at the Candidate Forum and there will be an event once per month. Look on social media for details, but also encourage those you know to come to meetings / become a member.	None

	The property at 1520 Madison Road is for sale. DCDC has been very engaged in the process and the buyer will engage with the neighborhood on the development. There have been a number of unhoused individuals in the business district. Steve has been in contact with service providers for solutions. The Cincinnati Preservation Society will be doing a presentation on the Cincinnati Tennis Club on September 16 at 5PM. The club's former president will be talking about the history. Brian, the program coordinator from Findlay Market, shared information regarding the Findlay Market shopping app. The shopping App was developed during COVID, but given the need still exists, the market is retaining the app. While you are always encouraged to attend in person, shoppers will fulfill orders Tuesday through Friday and deliver to the greater Cincinnati area. Pickup is also available. Any orders placed before 11:59PM will be fulfilled the next day. A representative from Kearney's office discussed policies. There was a question about speed humps. 




