Welcome	President Freeman Durham called the meeting to order at 7:02 p.m. Approximately 35 people attended the meeting online and via telephone.	None
1. Cincinnati Police Report	Officer Peery Locke discussed the crime statistics for October (posted on the website prior to the meeting and attached). Officer Locke reminded attendees that, as the holidays approach, to: (1) keep "your junk in your trunk" to prevent thefts from cars; (2) make sure that key fobs are not left in cars; (3) consider scheduling package deliveries or have the packages delivered to a neighbor who will be home at the time of delivery if you will not be home. 2. Bush Recreation Center Report	Vanessa Henderson reported on the information listed on the Recreation Commission sheet (attached). Contact Ms. Henderson for further information (vanessa.henderson@cincinnati-oh.gov).	None
3. Mercy Montessori Presentation	Patty Normile, principal of Mercy Montessori, along with Joe Butkovich, Mercy Board President, and Damian Billy, Past Board President, attended the meeting. Ms. Normile led the attendees through a slideshow presentation (attached). She stressed that the Mercy Montessori is concerned about the historic nature of the buildings and respectful of the historic nature of East Walnut Hills. She talked about the mission of Mercy Montessori and wanting to be good stewards. Mercy Montessori leases the school buildings, a vacant lot on Grandview, and the parking lot on the east side of Grandview from the Sisters of Mercy, who are located in North Carolina. The Sisters own four historic houses on the west side of Grandview (and a fifth that cannot be seen from Grandview). Ms. Normile said that the school wanted to continue to educate students with all the resources needed to do that in the same space while possibly expanding is some regards. Ms. Normile said that staff and current parents have provided input on potential uses for the properties owned by the Sisters. There was discussion among attendees about possible re-use of the properties, from returning them to single family residential (selling the properties?) to other uses shown on the slideshow. Mercy Montessori is seeking input on this project through December 2021. From January 2022 through March 2022 the possibilities will be narrowed. Financial feasibilities of top ideas will be vetted March 2022-December 2022. A proposal for the project will be submitted to the Sisters in January 2023. A question was asked if the community would continue to be involved in the project after December 2021 Discussion ensued on that issue and Mr. Butokovich stated that Mercy Montessori wants to be in communication with the neighbors and the community and hear their voices. They will work on a vehicle for ongoing further communication with the community and circle back on that.	None
4. Approval of Monthly Meeting Minutes	Freeman asked if there were revisions to the October 6, 2021 monthly Assembly Minutes (posted on the website prior to the meeting). There being no revisions, the October Minutes were deemed approved as posted.	None
5. Treasurer's Report	Freeman reported on the September 2021 Treasurer's Report that had been posted online prior to the meeting (see attached Report). Income for the month was \$5500 from parking lot revenues. Expenses were \$8482 for mural (Beautification) expenses; website, social media and kiosk expenses (Outreach); event expenses; and parking lot expenses. There was a \$2900 deficit for the month. Cash balance on hand is \$53,471.	None
6. Membership Committee Report	Valerie Daley reported that it's renewal time for annual dues.	None
7. Events Committee Report.	Christine Johnson reported. The Monthly Trash Walk will take place on November 6. at 9:00 a.m. and will start at the Evanston Rec Center.	None
8. Infrastructure Committee Report	Deb Dereshkevich reported. (1) The bench program sponsored by the Cincinnati Parks Foundation is on hold, so that the idea about having a bench placed in Annwood Park in memory of Sue Fullen is not possible – at least in the short run. Another idea suggested was to place markers in the pots in the business district as a memorial to Sue. (2) The paperwork to get the Farmers Market up and	None

9. Parking	running is being worked on. The Committee is looking for a couple of community members to be involved in the management. (3) Melissa McVay from the City's Transportation Department reached out to inform EWHA Board that the City is revamping its pedestrian safety program to focus on traffic calming. Two possible ways to calm traffic are suggested: bump outs and speed cushions. Each community is asked to submit two street segments. All submissions will be scored and ranked. Funding of projects will be based on ranking and not all projects can be funded. Discussion ensued about possible submissions and other traffic calming measures. Deb requested that people submit further ideas to the EWHA Board via the contact link on the EWHA website. Rick Boydston reported. The Madison lot lease with the City is up for renewal in	None
Committee Report	December. He and the Parking Committee are working on terms for the renewal. There is paid parking in both the Madison and Woodburn lots, managed by Star Parking. Monthly 24/7 parking is also available via permits. There are currently 47 monthly permit holders, the highest number ever.	
10. Development Committee Report	Drew Gores introduced Stephen Dronen from Kean Ventures, the developer of the Woodburn Exchange. He reported that the construction is on schedule and that the apartments are likely to be available late summer, early fall. He'll have a better idea of the timing once winter hits. A harsh winter will slow down the process. The commercial part of the development will likely be available on a similar timetable. The developer is actively recruiting and will work with the EWHA Board, the EWH Business Association, and The Walnut Hills Redevelopment Foundation to determine a process for community input on the commercial tenants. There will be 322 apartment units in this Phase I. Commercial/retail space is large enough for 5,6 or more tenants, depending on the space needed by tenants. Dronen says the developer plans on another robust process with the community when looking to develop Phase II and III. Drew then reported on the following: (1) Hello Honey is looking to be open sometime in November; (2) On November 19 Magnetic Homes is going in front of the Planning Commission to request the subdivision of the properties Magnetic owns on Moorman Avenue; (3) Symposium, a cafe by day and a wine bar by night, will be opening in the former Cafe de Sales space. O Pie O has closed, but the same owners will be bringing a new concept to the space soon; (4) The dedication of the new mural on the wall along WH Taft will take place at 7:00 p.m. on November 12 at the mural site. People will then go to Woodburn Brewing to continue the celebration.	None
11. NBDSF Grant Approval	Kathleen Armstrong from <i>On My Mat Yoga</i> , reported for the EWHA Business Association. The EWHA Board and the Business Association are asking for a vote of approval for the following allocation of the \$3500 NBD grant funds from the City: \$2000 for business marketing and promotion and \$1500 for WoW and other business association supported events. No attendees had questions. Upon a motion and second to approve the NBD \$3500 grant funds allocation as presented by Kathleen, the attendees unanimously voted to approve.	Unanimous Approval


The Buildings (from the south to the north)
