Welcome	President Tony Fischer called the meeting to order at 7:01 p.m.	
1. Cincinnati Police Report	Officer Perry Locke presented the crime statistics for EWH for October 2019. A copy of the crime statistics is attached. There was a discussion about parking meters in front of the San Marco and Sgt. Pompey reminded the attendees that metering of parking is an issue for DOTE and not for the police. Captain Jones reminded attendees, that with the holiday season, people had to be careful about having packages delivered to their front doors where the packages are subject to theft. He recommended having packages delivered to a work address or to occupied neighbor's house. If left at your home, he said, then consider adding special instructions such as "place in the rear of the house".	None
2. Bush Recreation Center Report	Drew Gores reported for Vanessa Henderson. Trunk or Treat was a success. Bush Recreation Center will be closed Nov 11 for Veteran's Day. From Nov 1-Nov 21, the Center is collecting canned goods for the holiday. Input is requested about what programs to offer at the Rec Center in 2020. Call 513-281-1286 with suggestions. 3. Acceptance October 2019 Meeting Minutes	The October 2, 2019 Monthly Meeting Minutes were posted to the EWHA website at <u>eastwalnuthills.org</u> prior to the meeting and, there being no revisions, were deemed approved as posted.	None
4. Former Anthem Site Presentation	Stephen Dronen from Fortus presented plans for landscaping and lighting for the proposed development on the former Anthem site. (1) Upon motion and second, the landscape plan, as presented, was approved by unanimous vote. (2) Stephen Dronen presented the lighting as follows: 3 blade signs backlit by LED lighting that are 3.5 ft. by 22 ft., backlit emblems at the top of the buildings in various locations, a ground sign in the wall at Woodburn and Taft that is approximately 6 ft by 20 ft. and two other smaller ground signs on the property. Rae Vuic stated that the property is governed by "CCP" signage regulations that would allow for 3 ft by 8 ft blades signs and smaller ground signs. She stated that she had asked both Stephen and the Caroline Kellam from the City to provide clarification as to which of the proposed signage was allowed under the zoning that applies to the property (CCP or something else?) and what may need a variance or other permissions from the Planning Department (through the PD process) or Buildings and Inspection to be installed. She stated that she had not received that information. Tony read from the EWHA October Board Minutes where that Board tentatively approved the 3.5 ft by 22 ft. blade signs [dependent upon Assembly approval] and took the position that CCP controls all other signs. Discussion ensued with concerns voiced by attendees that (a) the blade signs were too big and were also out of character with the signage on the historic buildings in the business district; (b) there were too many signs overall; (c) the buildings were too lit up; and (d) the lighting may not comply with applicable zoning. It was agreed that no vote would be taken at the Assembly and that the developers should return at the December meeting to re-present. 
